Certification Scope 驗證範圍說明：

- (一) **Processing** : Production procedures such as heating, drying, smoking, mixing, grinding, tableting, stirring, separation, distillation, extraction, fermentation, pickling, dehydration, shelling, milling, or freezing of organic raw materials, or other processes sufficient to change the physical or chemical characteristics or capable of substantially transforming the original product.
- 加工** : 對有機原料進行加熱、乾燥、燻製、混合、研磨、製錠、攪拌、分離、蒸餾、抽出、發酵、醃漬、脫水、脫殼、碾製、冷凍或其他足以改變原產品理化性質或其實質轉型之製造程序。
- (二) **Packaging** : Selection, washing, cutting, or packaging of organic raw materials that do not change the physical or chemical characteristics of the original product.
- 分裝** : 對有機原料進行選別、洗淨、分切等作業，其過程不應改變原產品之理化性質。
- (三) **Distribution** : Original packages or labels of an organic agricultural product and in-conversion agricultural product changed in a way that affects the organic integrity of that agricultural product.
- 流通** : 改變有機農產品及有機轉型期農產品之原包裝或原標示，致影響農產品有機完整性之過程。
- (四) **Private label** : Organic agricultural products or in-conversion agricultural products are entrusted to another operator in production, processing, packaging or distribution procedure by an entruster or a client. The entruster or a client is labeled as the operator of the agricultural products with information below: name, address and phone number.
- 自有品牌** : 委託農產品經營者生產、加工、分裝、流通有機或有機轉型期農產品，並以委託人或定作人資訊標示農產品經營者、地址、電話。
